ABOUT HEAD START



United Community Action Partnership (UCAP) Head Start provides a comprehensive approach to the well-being of children and families.

This two-generational approach focuses not only on the child but also the parents. Head Start partners with families to implement services that prepare children academically, physically, and socially to enter kindergarten. As of July 1, 2016, UCAP has been the grantee of two Head Start/Early Head Start Grants. The program also receives state funded Early Head Start, as well as additional supplemental funding through other sources.

Grant 05CH010360 serves Cottonwood, Jackson, Lincoln, Lyon, and Redwood Counties. Grant 05CH8402 serves Kandiyohi, Meeker, McLeod, and Renville Counties.

Head Start provided services to 277 preschool aged children in Grant 05CH802 and 202 children in Grant 05CH010360, ages 3-5, in a classroom setting, for a total of 479 children.

Head Start maintained an average monthly enrollment of 100%.





92% of children in Grant 05CH8402 and 94.5% of children in Grant 05CH010360 served were income or categorically eligible for Head Start.





Of those children enrolled in Grant 05CH8402:

- 63.5% of children enrolled were under 100% of poverty.
- 7% of children enrolled were receiving public assistance, such as Minnesota Family Investment Program (MFIP) or Supplemental Security Income (SSI).
- 2.5% were either homeless or a foster child.

19% were between 100% and 130% of federal poverty line.

Of those children enrolled in Grant 05CH010360:

- 76% of children enrolled were under 100% of poverty.
- 8% of children enrolled were receiving public assistance, such as Minnesota Family Investment Program (MFIP) or Supplemental Security Income (SSI).
- 4.5% were either homeless or a foster child.
- 5.5% were between 100% and 130% of federal poverty line.

HEALTH OUTCOMES

Health outcomes Grant 05CH8402:

- 85% of enrolled children received medical exams and were up-to-date on age appropriate preventive and primary health care.
- 89% of children at the end of the enrollment year were up-to-date on all immunizations appropriate for their age.
- 79% of children received a professional dental exam during the program year. Of those children who received a dental exam, 28% required treatment.
- 48% of children who needed dental treatment received it.

UCAP Head Start received a Classroom Assessment Scoring System (CLASS) review by the Office of Head Start in October, 2017. No corrective action was required. The financial audit of 2016 had no findings and demonstrated fiscal integrity through effective control and accountability.

Health outcomes Grant 05CH010360:

- 90% of enrolled children received medical exams and were up-to-date on age appropriate preventive and primary health care.
- 87% of children at the end of the enrollment year were up-to-date on all immunizations appropriate for their age.
- 57% of children received a professional dental exam during the program year. Of those children who received a dental exam, 38% required treatment.
- 32% of children who needed dental treatment received it.

HEAD START VOLUNTEERS

Head Start had 740 volunteers throughout the 2016 – 2017 school year. Of those volunteers, 537 (73%) were current or former Head Start parents.

SCHOOL READINESS

Head Start students made substantial gains across all learning domains during the 2016-2017 school year.

School readiness goals were achieved by 76.4% of children. Goals in social-emotional development, physical development, language, and literacy were generally met. While most students made significant gains in early math skills, on average, the program fell just short of meeting its goals. When families attended parent-teacher conferences, children were more likely to have met all school readiness goals.

EARLY HEAD START



United's Early Head Start is a state and federal funded program for low-income pregnant women and families with infants and toddlers ages 0 – 3. The program promotes the relationship development between parent and child, understanding that parents are a child's first and most important teacher.

State and Federal Early Head Start provided services to 143 infants, toddlers, and/or pregnant women in a home-based or center setting. Early Head Start maintained an average monthly enrollment of 100%.



94% of children served were income or categorically eligible for Federal Early Head Start.

Of those children who were enrolled:

- 73% of children enrolled were under 100% of poverty.
- 16% of children enrolled were receiving public assistance, such as Minnesota Family Investment Program (MFIP) or Supplemental Security Income (SSI).
- 1% were either homeless or a foster child.

HEALTH OUTCOMES

- 67% of enrolled children received medical exams and were up-to-date on age appropriate preventive and primary health care.
- 77% of children at the end of the enrollment year were up-to-date on all immunizations appropriate for their age.
- 48% of children received a professional dental exam during the program year.

CHILD OUTCOMES



Early Head Start infants and toddlers demonstrated gains across all areas of development.

Dramatic gains were found in social skills, physical development, and cognitive development. Two-year olds were on track in development to transition into Head Start or other preschool options. Gains were significant in physical development and early literacy. Early literacy and early math were the domains with the fewest percentage of children meeting school readiness goals for two-year-olds.
